BM3R1, a transcriptional regulator from Bacillus bacteria, can repress gene transcription by binding its cognate operator sequence (CGGAATGAACGTTCATTCCG) and occluding polymerase activity. This regulator is part of the ATCC® Synthetic Biology Yeast Tool Kit (Detailed information is described in the ATCC® Synthetic Biology Solutions User Guide). The synthetic promoter pGPD- BM3R1 (ATCC® SB-1066™) can be paired with this regulator to control gene expression in Saccharomyces cerevisiae. Before opening the vial, centrifuge at 6,000 x g for 30 seconds. Add 30 μ L of Molecular Grade Water and incubate the vial at 4°C overnight to dissolve the DNA. Each vial contains 2-3 μ g plasmid DNA (measured by PicoGreen® dsDNA quantitation assay).
