pENTR_L1L2_BetI-VP64 contains an ATCC synthetic activator flanked by two Gateway® recombination *att* sites (*attL1* and *attL2*). The activator is a fusion of the TetR homolog Bet1 and a VP64 activation domain. It can bind and activate the ATCC synthetic promoter BetI-CYC1MIN (ATCC® SB-1055™). Before opening the vial, centrifuge at 6,000 x g for 30 seconds. Add 30 µL of Molecular Grade Water and incubate the vial at 4°C overnight to dissolve the DNA. Each vial contains 2-3 µg plasmid DNA (measured by PicoGreen® dsDNA quantitation assay).
