Handling Procedures

Unpacking and storage instructions:

- 1. Check all containers for leakage or breakage.
- 2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

Complete medium: The base medium for this cell line is ATCC-formulated Dulbecco's Modified Eagle's Medium, Catalog No. 30-2002. To make the complete growth medium, add the following components to the base medium: fetal bovine serum to a final concentration of 10%.

Subculturing procedure:

Medium Renewal: Every 2 to 4 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at $2 \times 10 = 500$ cells/ml and maintain between $1 \times 10 = 500$ and $1 \times 10 = 500$ cells/ml.

Reagents for cryopreservation: Complete growth medium supplemented with 5% (v/v) DMSO (ATCC 4-X)
