After autoclaving, add 2 mL sodium bicarbonate (1 M), 0.1 mL ferric sodium EDTA (7.5 mM), 5 mL KH<sub>2</sub>PO<sub>4</sub> (0.4 g/L) 10 mL NH4Cl (1 M)

1 mL Nitrosomonas trace elements

The Nitrosomonas trace element mixture includes 30 mg  $H_3BO_3$ , 100 mg  $MnCl_2 \cdot 4H_2O$ , 190 mg  $CoCl_2 \cdot 6H_2O$ , 24 mg  $NiCl_2 \cdot 6H_2O$ , 2 mg  $CuCl_2 \cdot 2H_2O$ , 144 mg  $ZnSO_4 \cdot 7H_2O$ , 36 mg  $Na_2MoO_4 \cdot 2H_2O$  and 12.5 ml HCl (25% = 7.7 M)
