Nitrogen flush and autoclave sealed

Post autoclave sterile additions:

10ml 2.5% cysteine HCl, 1M NaCO₃ to pH 7.8 can be 25ml, 0.1ml 100% acetylene per 10ml

Nitrogen atmosphere, in dark, shaking if grown with acetylene, 24 hrs then pulse again with acetylene
