Grow in Modified Shieh broth/agar:

Add per liter (per 500 mL)

Tryptone: 5.0 g (2.5 g)

Yeast Extract: 2.0 g (1.0 g)

Distilled Water: 1.0 L (500 mL)

Add the indicated volume of stock solutions:

$\text{CaCl}_2 \cdot 2\text{H}_2\text{O}$ 45.6 μM

For a 1000X stock solution: add 1.34 g in 200 mL distilled water

Add 1.0 mL per liter (0.5 mL per 500 mL)

KH_2PO_4 (monobasic) 1.1 mM

For a 1000X stock solution: add 10 g in 200 mL distilled water

Add 3 mL per liter (1.5 mL per 500 mL)

$\text{MgSO}_4 \cdot 7\text{H}_2\text{O}$ 1.2 mM

For a 100X stock solution: add 15.0 g in 500 mL distilled water

Add 10 mL per liter (5 mL per 500 mL)

$\text{FeSO}_4 \cdot 7\text{H}_2\text{O}$ 3.6 μM

For a 100X stock solution: add 0.02 g in 200 mL distilled water

Add 10 mL per liter (5 mL per 500 mL)

Adjust for final pH of ~ 7.2

Add 10 g agar (5.0 g) for plates.
