Description

Aerococcus mayonii strain BD502 is a gram-positive bacterium from the Aerococcaceae family that was isolated from human blood in Rochester, Minnesota, United States, on March 18, 2021. This strain was identified through whole-genome sequencing. It grows on blood agar at 37°C in aerobic, dark conditions and is cryopreserved with glycerol and components like TSB, peptone (bovine bone stock, bovine casein, and porcine pancreatic extract). This culture requires BSL-2 safety precautions due to its potential hazard to humans.
