5 mM NH₄NO₃
1 mM MgSO₄·7H₂O,
1mL of trace element solution per L 0.2% pyruvate

1.5% agar added for solid media

12.5 mL HCl [25%]

2.1g FeSO₄·7 H₂O

30 mg H₃BO₃

100 mg MnCl₂·4 H₂O

190 mg CoCl₂·6 H₂O

24 mg NaCl₂·6H₂O

2 mg CuCl₂·2H₂O

144 mg ZnSO₄·7H₂O

36 mg Na₂MoO₄·2H₂O

Liquid culture grown at 30°C aerobically in the dark for 3 days with shaking at 225 rpm.
Plate cultures grown at 30°C aerobically in the dark for 7 days.
