Depositor-recommended growth conditions: Infect 1×10^6 ISE6 tick cells with 0.5 mL bacteria and culture in L-15B300 complete medium supplemented with 10% fetal bovine serum, 5% tryptose phosphate broth, 0.1% bovine lipoprotein cholesterol concentrate, and 10 mM HEPES.
