The partly purified microsome fraction can be prepared from the tissue of RSV-induced tumors will produce new tumors in almost all chicks of a susceptible strain injected s.c. or i.m. with 0.2-0.5 mL of a 1:100 dilution. This strain probably has several viruses in a complex mixture. To maintain the mixture, the virus should be propagated in vivo (SPF chickens).
