Description

Human respiratory syncytial virus strain B WV/14617/85 is propagated in Vero cells (ATCC CCL-81). This viral strain was isolated in the secretion from the endotracheal tube of an infant with pneumonia and was deposited by the National Institutes of Allergy and Infectious Diseases. It has applications in respiratory disease research.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: Vero (ATCC CCL-81)

Effects: CPE; cell rounding; cell sloughing; syncytia

Complete medium:

EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020)

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: Plate cells 24-48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.
