Incubation: In CE, incubate 8 days at 35° C; in Vero cells, incubate 8-10 days at 34-35° C.

Possesses CF antigens in common with *R. typhi* and *R. prowazekii* with antisera prepared in GP, Rab, and Ha; however, MIF test with mouse antisera bled by ear after infection or immunization are quite specific. Highly infectious.
