Reference antisera against *Coxiella*, *Wolbachia*, *Chlamydia* and *Anaplasma* spp. And 14 members of the genus *Rickettsia* all failed to react significantly. Cross-reactivity was observed with *Cowdria ruminantium* (Kiswani isolate). Identification is recommended by 16S rRNA sequence--GenBank accession number AF042496. Dense forms enter cytoplasm and reticulated forms develop. These forms develop to dense forms that are released from the cell.
