Heat stable, resistant to chloroform and ether, agglutinates guinea pig RBC (after treatment of virus with RDE). The material has tested positive for mycoplasma contamination (*A. laidlawii*) and it is suggested that it be treated with solvent to inactivate the mycoplasma prior to passage.
