## Growth Conditions

**Host:** FRhK-4 (ATCC CRL-1688)

**Effects:** cell degeneration; cell rounding; cell sloughing; CPE

**Complete medium:**

EMEM (ATCC® 30-2003™) + 10% FBS (ATCC® 30-2020™)

**Temperature:** 34.5°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 70-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1).

Adsorb 1-2 hours at 34.5°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

- **Incubation:** 14-28 days

## Handling Procedures

**Mycoplasma contamination:** Not detected

## Notes

To make VR-1541, VR-2089 was freeze-thawed three times, then filter-sterilized through a 0.45 µm and two 0.2 µm acrodiscs before inoculating host cells.
