Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

**Recommendations for infection:** For best results, plate cells 24-48 hours in advance. Infect at about 80%-90% confluence using a multiplicity of infection (MOI) of 0.01 to 1.0. Incubate at 37°C in a humidified, 5% CO<sub>2</sub> atmosphere for 3 to 6 days, until CPE are well advanced in 100% of the culture.

**Incubation:** Incubate at 37°C in a humidified, 5% CO2 atmosphere for 3-6 days, until CPE are well advanced in 100% of the culture.
