Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Host: BHK-21 [C-13] (ATCC CCL-10)

Effects: cell rounding; cell sloughing; CPE

Complete medium:

EMEM (ATCC® 30-2003™) + 1% FBS (ATCC® 30-2020™)

Temperature: 37°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: Plate cells 24-48 hours prior to infection and infect when cultures are 80-95% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere, rocking every 15 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

Incubation: 1-3 days
