Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: A-72 (ATCC CRL-1542)

Effects: cell rounding; cell sloughing; CPE

Complete medium:

DMEM (ATCC® 30-2002™) + 2% FBS (ATCC® 30-2020™)

Temperature: 34°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: Plate cells 24-48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 34°C in a humidified 5% CO₂ atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

Incubation: 2-4 days

Notes

Three freeze-thaw cycles performed at harvest. Cross-reacts with canine coronavirus, TGE virus of swine, and Human coronavirus 229E.
