## Growth Conditions

**Host:** A549 (ATCC CCL-185)

**Effects:** cell clustering; cell death; cell rounding; CPE

**Complete medium:**

F-12K (ATCC® 30-2004™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24-48 hours in advance and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus diluted to provide a MOI of 0.01. Adsorb for 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** Incubate infected culture for 1-3 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE are well advanced through 90% of the culture.
