## Growth Conditions

**Host:** LLC-MK2 Derivative (ATCC CCL-7.1)

**Effects:** cell rounding; CPE

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted in VGM to provide an optimal MOI (e.g. MOI 0.1). Adsorb 2-2.5 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding VGM.

**Incubation:** 5 to 6 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere
