Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI 0.1. Adsorb 1-2 hours at 37°C in a humidified 5% CO_2 atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium. **Incubation:** 1-4 days
