Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

Temperature: 33°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: For best results, infection should be performed on a 80-90% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm²), optimized for propagation (e.g. MOI 0.005 - 0.01 recommended). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 33°C in a humidified 5% CO 2 atmosphere, while rocking. End adsorption by adding virus growth medium.

Incubation: 1-7 days at 33°C in a humidified 5% CO₂ atmosphere while rocking, until CPE is progressed through 80% of the monolayer.
