## Growth Conditions

**Host:** HeLa (ATCC CCL-2)

**Effects:** cell degeneration; cell sloughing; CPE

**Complete medium:**

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 33°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** For best results, infection should be performed on a 80-90% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm<sup>2</sup>). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 33°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 1-7 days at 33°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.

VR-1809™ has been treated for *Mycoplasma orale* at the ATCC using diethyl ether. The original item number was VR-504™.
