1. Thaw the vial at room temperature and immediately place on ice. Avoid exposing the RNA to repeated freeze-thaw cycles as it may result in degradation.
 2. Gently mix the sample to ensure an even distribution of material.
 3. Briefly centrifuge the tube before opening to ensure all liquid is at the bottom.

RNA is easily degraded. Take extra precautions against contamination by using new gloves and clean lab coats when working with RNA. Use only RNase-free lab materials when handling this product. Vortexing can damage RNA. Gentle pipetting is highly recommended. Aliquoting is highly recommended to avoid multiple freeze-thaws, which can damage RNA.
