### Description

Murine pneumonia virus strain 15 is propagated in BHK-21 [C-13] cells (ATCC CCL-10). This animal virus was isolated from the lungs of mice and was treated for *Mycoplasma* sp. using a mycoplasma removal agent.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Host: BHK-21 [C-13] (ATCC CCL-10)

Effects: CPE; cell degeneration; cell rounding

**Complete medium:** 

EMEM (ATCC 30-2003) + 10% FBS (ATCC 30-2020)

Temperature: 37°C

Atmosphere: 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** For best results, infection should be performed on a 80-90% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm<sup>2</sup>). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 2-3 hours at 37°C in a humidified 5% CO<sub>2</sub>atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 5-12 days at 37°C in a humidified 5% CO<sub>2</sub>atmosphere, until CPE is progressed through 80% of the monolayer.

#### Notes

ATCC VR-1819 was treated for *Mycoplasma* sp. at the ATCC by three passages with media supplemented with an antibiotic (Mycoplasma Removal Agent – Bio-Rad catalog BUF035). The original item number was ATCC VR-25.
