Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

McCoy's 5A Modified Medium (ATCC® 30-2007™) + 2% FBS (ATCC® 30-2020™)

Temperature: 37°C

Atmosphere: 95% Air, 5% CO2

**Recommendations for infection:** For best results, infection should be performed on a 65-75% confluent, 18-24 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm $^2$ ). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 37°C in a humidified 5% CO $_2$ atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2-4 days at  $37^{\circ}\text{C}$  in a humidified 5% CO<sub>2</sub>atmosphere, until CPE is progressed through 80% of the monolayer.
