Description

Enterovirus D68 strain US/MO/14-18947 is propagated in RD cells (ATCC CCL-136). This strain was isolated from a nasopharyngeal swab from a patient with respiratory illness in Missouri in 2014 and was deposited by the Centers for Disease Control and Prevention. It has applications in infectious disease and respiratory disease research.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: RD (ATCC CCL-136)

Effects: CPE; cell rounding; cell sloughing

Complete medium:

EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020)

Temperature: 33°C

Atmosphere: 95% Air, 5% CO₂

Recommendations for infection: Plate cells 24-48 hours prior to infection and infect when cultures are 80-95% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.01-0.001). Adsorb 1-2 hours at 33°C in a humidified 5% CO₂ atmosphere. End adsorption by adding virus growth medium.

Incubation: 2-3 days
