Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 1-2 hours at 33°C in a humidified 5% CO₂ atmosphere rocking continuously at 0.5 rpm. End adsorption by adding virus growth medium. **Incubation:** 2-3 days at 33°C in a humidified 5% CO₂ atmosphere, until CPE is progressed through 80% of the monolayer.
