Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Host: CV-1 (ATCC CCL-70) Effects: cell rounding; cell sloughing; CPE Complete medium: EMEM (ATCC<sup>®</sup> 30-2003<sup>™</sup>) + 2% FBS (ATCC<sup>®</sup> 30-2020<sup>™</sup>) Temperature: 37°C

Atmosphere: 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 18-48 hours prior to infection and infect when cultures are 60-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.01-0.1). Adsorb 1-2 hours at 37°C in a humidified 5%  $CO_2$  atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 4-7 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.

#### Myxoma virus VR-1829

This virus is highly virulent for domestic rabbits with a mean period of 11 days between i. d. inoculation of small doses of virus and death. This strain was taken to Switzerland by G. Bouvier, and was used by A. Delillie in June, 1952 to initiate European outbreaks of myxomatosis.
