Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g 0.05). Adsorb 1 -2 hours at 35.5°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium. Incubation: 2-3 days at 35.5°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is

progressed through 85-90% of the monolayer.
