## Growth Conditions

**Host:** VERO C1008 [Vero 76, clone E6, Vero E6] (ATCC CRL-1586)

**Effects:** CPE; cell rounding; cell sloughing

**Complete medium:** EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 18-24 hours prior to infection and infect when cultures are 60-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 4-6 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.
