will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

**Host:** Aedes albopictus clone C6/36 (ATCC CRL-1660)

Effects: cell sloughing; CPE

Complete medium:

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

Temperature: 28°C

Atmosphere: 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 24 hours prior to infection and infect when cultures are 80% confluent. Remove medium and then wash monolayer with PBS or serum free medium prior to inoculation. Inoculate with a small volume of inoculum (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.01). Adsorb for 1 hour at 28°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 4-6 days at  $28^{\circ}$ C in a humidified 5%  $CO_2$  atmosphere, until CPE is progressed throughout monolayer.
