Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Host: Aedes albopictus clone C6/36 (ATCC CRL-1660)

Effects: cell rounding; cell sloughing; CPE

**Complete medium:** 

EMEM (ATCC<sup>®</sup> 30-2003<sup>™</sup>) + 5% FBS (ATCC<sup>®</sup> 30-2020<sup>™</sup>)

Temperature: 28°C

**Recommendations for infection:** Plate cells 18-24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g., 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g., 0.01). Adsorb 1-2 hours at 28°C in a humidified, air atmosphere incubator. End adsorption by adding virus growth medium.

**Incubation:** 6-8 days at 28°C in a humidified, air atmosphere incubator, until CPE is progressed through 80% of the monolayer.
