## Growth Conditions

**Host:** Vero (ATCC CCL-81)

**Effects:** cell rounding; cell sloughing; CPE

**Complete medium:**

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 16-48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 4-5 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.

Derived by adaptation of primary cell culture product ATCC® VR-1039™ to Vero cells (ATCC® CCL-81™). ATCC® VR-1867™ and ATCC® VR-1039™ have not been compared for sequence or infectivity in primary cell culture and tissue culture.
