## Growth Conditions

**Host:** HeLa (ATCC CCL-2)

**Effects:** cell rounding; cell sloughing; CPE

**Complete medium:**

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 33°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 18-24 hours prior to infection and infect when cultures are 70-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1.5-2.0 hours at 33°C in a humidified 5% CO<sub>2</sub> atmosphere while rocking. End adsorption by adding virus growth medium.

**Incubation:** 6-7 days at 33°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.
