## Growth Conditions

**Host:** LLC-MK2 Derivative (ATCC CCL-7.1)

**Effects:** cell rounding; cell sloughing; CPE

**Complete medium:**

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 36°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** Plate cells 18-24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 2 hours at 36°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 3-4 days at 36°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80-90% of the monolayer.
