Mycoplasma contamination: Not detected

Notes

Ducks (1-2 week) become ill in 1-2 days and die in 3-5 days. Lesions occur in the liver and brain of infected ducks. Survives heating at 56°C for 90 minutes. Not stable after lyophilization.
