## Growth Conditions

**Host:** WI-38 (ATCC CCL-75)

**Effects:** CPE; cell rounding; cell sloughing

**Complete medium:**

EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020)

**Temperature:** 33°C

**Recommendations for infection:**

Plate cells 16-48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 1.5). Adsorb 1-2 hours at 33°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

**Incubation:** 2-4 days at 33°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.

ATCC VR-1999 was derived from ATCC VR-508 following treatment with diethyl ether to remove *Mycoplasma* contamination.
