Elicits fibrosarcoma formation and ocular disease in chickens (Beard, J.W., Adv. Cancer Res. 7: 1, 1963). This strain, of archival interest, is likely a mixture of viruses. Any of a number of isolates or clones (i.e. ATCC 45000) of Rous sarcoma virus would better serve most researchers.
