Ross River Virus strain T-48 is tissue culture–adapted to be cultivated in BHK-21 [C-13] (ATCC CCL-10) cells. This strain was isolated in 1959 from *Aedes vigilax* in Australia. **Strain designation:** T-48 (TC-adapted) **Deposited As:** Ross River virus

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# **Growth Conditions**

Host: BHK-21 [C-13] (ATCC CCL-10) Effects: CPE; cell sloughing; cell degeneration Complete medium: EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020) Temperature: 37°C Recommendations for infection:

Plate cells 1-2 days days prior to infection and infect when cultures are 70-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.03). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere. End adsorption by adding virus growth medium.

#### Incubation:

2-4 days at 37°C in a humidified 5%  $\rm CO_2$  atmosphere, until CPE is progressed through 90% of the monolayer.
