Description

Coxsackievirus A16 strain G10 was derived by cell culture adaptation of ATCC VR-174 to Caco-2 cells (ATCC HTB-37). The strain was originally isolated from the feces of a 2-year-old human male in South Africa.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: Caco-2 [Caco2] (ATCC HTB-37)

Effects: cell rounding; cell sloughing; cell detachment

Complete medium: EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020)

Temperature: 37°C

Recommendations for infection: Plate cells 1-2 days days prior to infection and infect when cultures are 70-90% confluent. Remove medium and inoculate with a small volume of virus (e.g., 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g., 0.1). Adsorb 1.5-2.5 hours at 37°C in a humidified 5% CO₂ atmosphere. End adsorption by adding virus growth medium.

Incubation: 4-6 days at 37°C in a humidified 5% CO₂ atmosphere, until CPE is progressed through 80-100% of the monolayer.
