Description

Bovine parainfluenza virus 3 strain SF-3 is propagated in BT cells (ATCC CRL-1390). This animal virus was isolated in 1958 from a calf showing signs of shipping fever in Maryland.

Strain designation: SF-3

Storage Conditions

Storage conditions: -70°C or colder

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Host: BT (ATCC CRL-1390)

Effects: cell rounding; cell sloughing; cell detachment; cell clumping

Complete medium: DMEM (ATCC 30-2002) + 2% Horse serum

Temperature: 37°C

Recommendations for infection: Plate cells 24-48 hours prior to infection and infect when cultures are 70-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere. End adsorption by adding virus growth medium.

Incubation: 3-5 days at 37°C in a humidified 5% CO₂ atmosphere, until CPE is progressed through 90-99% of the monolayer.
