Effects: cell rounding; cell degeneration; cell sloughing; cell detachment **Complete medium:** EMEM (ATCC 30-2003) + 2% FBS (ATCC 30-2020) **Temperature:** 37°C

Recommendations for infection: Plate cells 24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.44). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere. End adsorption by adding virus growth medium.

Notes

This strain provides a biological pure culture of a novel pathogenic porcine respiratory coronavirus (PRCV) and a vaccine derived therefrom effective against PRCV infection and Transmissible gastroenteritis virus (TGEV) infection. The virus produces a moderate pneumonia in pigs. There is no indication of human health hazard.
