Tumors harvested directly from chickens. May be necessary to add antibiotics before inoculating animals. C-type RNA tumor virus; labile; antigenically distinct from avian tumor viruses of sub-groups A, B and C. Seed stock should be prepared in vivo to preserve the host range and oncogenic spectrum of this unusual isolate. Most Rous strains infect mammalian cells with difficulty.
