Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Growth Conditions

**Host:** D-17 (ATCC CCL-183)

**Effects:** cell degeneration; cell rounding; CPE

**Complete medium:**

EMEM (ATCC® 30-2003™) + 2% FBS (ATCC® 30-2020™)

**Temperature:** 36°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

**Recommendations for infection:** For best results, infection should be performed on a 80-90% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm<sup>2</sup>), optimized for propagation (e.g. MOI 0.01-0.1 recommended). Wash monolayer two times with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 36°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 15-20 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 3 to 6 days at 36°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.
