### Description

Human herpesvirus 2 strain MS, or Herpes simplex virus 2 (HSV-2), is propagated in Vero cells (ATCC CCL-81). This strain was isolated in 1961 from the brain of a 50-yearold, female patient with multiple sclerosis in Iceland and was deposited by the Centers for Disease Control and Prevention. This product has applications in infectious disease research and sexually transmitted disease research.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

**Recommendations for infection:** Plate cells 24 hours prior to infection and infect when cultures are 90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere while rocking continuously. End adsorption by adding virus growth medium.
