Description

Simian foamyvirus type 7 strain Pan 2 (CV-11) is propagated in 293 [HEK-293] cells (ATCC CRL-1573). This strain was derived from a sympathetic nerve explant from chimpanzee (A-2) with experimental kuru. This virus is not demonstrated to be cause of kuru syndrome.
