Description

Simian foamyvirus type 4 strain 1224 is propagated in BHK-21 [C-13] cells (ATCC CCL-10). This strain was isolated from the throat swab of a squirrel monkey (*Saimiri sciureus*).

Ether, acid (pH 3.0) and heat (50°C for 30 minutes) sensitive. No HA or hemolysin. No neutralization test cross-reactions to types 1, 2, 3, 5, 6 or 7 simian foamyviruses.

Syncytium-forming. Nonpathogenic in common laboratory animals or 1-day-old mice held 2 years. Possible mycoplasma contamination.
