Simian foamyvirus type 5 strain 1557 is propagated in HeLa cells (ATCC CCL-2). This strain was isolated from the throat swab of a *Galago crassicaudatus panganiensis* and is sensitive to ether, acid, and heat.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Ether, acid (pH 3.0), and heat (50°C for 30 minutes) sensitive. No HA or hemolysin. No cross-reactions, in neutralization test, to types 1, 2, 3, 4, or 7 simian foamyviruses. Syncytium forming. Nonpathogenic in common laboratory animals or suckling 1-day-old mice held 2 years. Positive for mycoplasma.
