Influenza A virus (H3N2) strain A/Port Chalmers/1/73 is propagated in SPF chicken embryonated eggs. This strain was isolated in 1973 from a human patient in Dunedin, New Zealand, during an influenza outbreak and was deposited by the Centers for Disease Control and Prevention. This product has applications in influenza research.

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.
